AmBank and 7-Eleven in 400 ATMs deal

In strategic tie up for convenience in banking, AmBank (M) Berhad today signed a strategic co-operation agreement with 7-Eleven Malaysia Sdn Bhd which will enable it to install 400 Automated Teller Machines (ATMs) at 400 7-Eleven stores nationwide.

The installation period of all 400 ATMs at 400 7-Eleven stores is expected to take approximately two years. To kick-start the installation, ATMs have been installed at nine 7-Eleven outlets located at the following areas in Kuala Lumpur - Jalan Hang Kasturi, Jalan Sultan Ismail, Jalan Kenanga, Berjaya Complex, Pandan Jaya, Pandan Indah, Taman Maluri, Taman Melati and Megamall Kuantan in Kuantan. These ATMs will operate from 2am to 12 midnight.

"It is timely for us to bring banking to a more simple and convenient level by tying up with 7-Eleven to install 400 ATMs at 400 7-Eleven stores nationwide to offer banking convenience to our customers. By implementing this, we want to position AmBank as the bank of choice to our customers," said Mohamed Azmi Mahmood, Managing Director, Retail Banking, AmBank (M) Berhad.

"The tie in with AmBank will bring more banking services to our customers" said Mr Ng Su Onn, Executive Director, 7-Eleven Malaysia Sdn Bhd.

The services available at AmBank's ATMs located at the 7-Eleven stores are cash withdrawal, fund transfer, utility bill payment, loan repayments such as hire purchase and housing loan, as well as inter-bank fund transfer.

AmBank's current ATM network nationwide as of 17 April 2008 consists of 348 terminals. This figure includes 223 onsite ATMs at AmBank branches and 125 offsite ATMs at shopping malls and complexes. Hence, by the end of the second year of collaboration with 7-Eleven, AmBank will have a total exceeding 748 ATMs. Our projections indicate that this will take AmBank from number six to number three in Malaysia in terms of the size of our ATM network - further proof that AmBank is on the move.

This collaboration will pave way for more strategic tie ups between both parties, who are leaders in their respective industries.
