AmInvestment Bank is Best Equity House
AmInvestment Bank Berhad ('AmInvestment Bank') has been awarded as "Best Equity House" at the fourth edition of the Alpha Southeast Asia Best Financial Institution Awards. The awards ceremony was held in Kuala Lumpur on 3 August.

The Alpha Southeast Asia Best Financial Institution Awards cover the Southeast Asia region including Indonesia, Malaysia, the Philippines, Singapore and Thailand.

Mr T C Kok, Managing Director, AmInvestment Bank said, "We are very pleased to receive the award for Best Equity House, a meaningful recognition for a year that has seen the bank as an outstanding partner to our clients. For the period under review (26 June 2009 - 28 June 2010), AmInvestment Bank led the IPO market, listing five out of 24 companies on Bursa Malaysia, raising RM775 million, and securing a 21% market share.

Other prominent deals during the year included the listing of TA Global Berhad ('TA Global'), the largest listing of a property development company on Bursa Malaysia for 2009, unlocking the value of its strategically located properties. The listing of TA Global raised RM230 million.

The listing of Shin Yang Shipping Corporation Berhad ('Shin Yang') raised approximately RM332.5 million. In 2009, Shin Yang ranked first in Malaysia based on the number of vessels owned and used for the transportation of goods for third parties, with a fleet of 245 vessels.

Additionally, AmInvestment Bank was the bookrunner for the accelerated book-building for the placement of Berjaya Sports Toto Berhad shares which attracted overwhelming demand.
