Tan Sri Azman Hashim receives Honorary Doctorate in Management from University Malaya

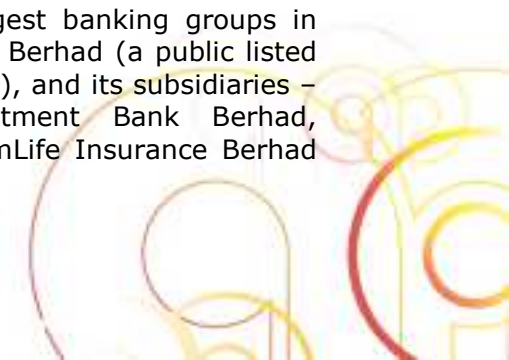
