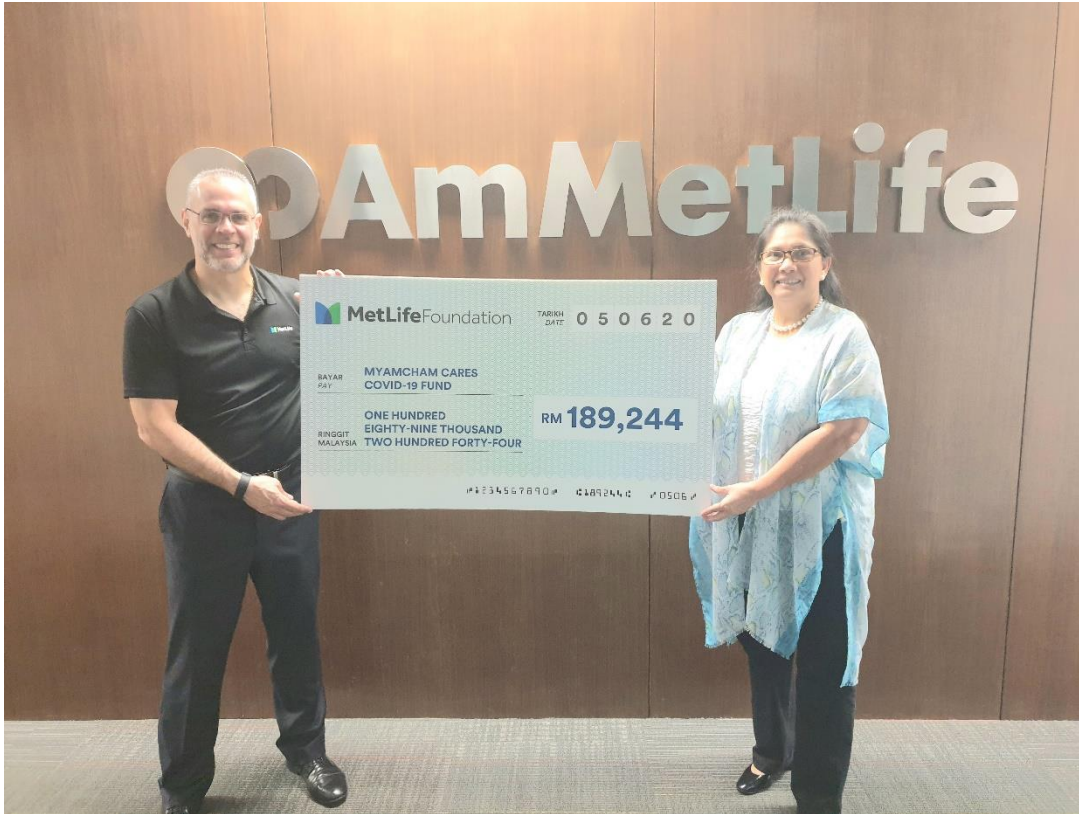


MetLife Foundation helps purchase personal protective equipment for healthcare workers
